HAR KI DUN & HATA VALLEY TREK

The Har Ki Dun valley, also known as the "Valley of Gods", is a cradle shaped hanging valley in the Garhwal Himalayas. It is surrounded by snow-covered peaks and alpine vegetation. It is connected to Baspa Valley by the Borasu Pass This valley is at

an altitude of approx 3500m above sea level and is snow-covered from the month of October to March.

Itinerary

Day 1: Dehradun - Sankri (2000m) (Drive / 200 kms / 6 - 7 hrs)

Day 2: Sankri (2000m) - Taluka - Seema (2560m) (Drive / 30 mins) (Trek / 4 - 5 hrs)

Day 3: Seema (2560m) - Har-ki-Dun (3566m) (Trek / 6 - 7 hrs)

Day 4: Har-ki-Dun (3566m) - Exploration to Hata Valley
Day 5: Har-ki-Dun (3566m) - Seema (2560m) (Trek / 3.5 - 4.5 hrs)

Day 6: Seema (2560m) - Taluka - Sankri (2000m) (Trek / 3.5 - 5.5 hrs)(Drive / 40 mins)

Day 7: Sankri - Dehradun (Drive / 200 kms / 6 - 7 hrs)

Cost: 13100/- PP + GST
